However, all costs of uninstalling, transporting and reinstalling the railing or fence are the buyer's sole responsibility. The material must not be returned to the factory without the prior written permission of Rampesetclôtures.com Inc.

This express warranty from Rampesetclôtures.com Inc is the only warranty and recourse against Rampesetclôtures.com Inc. with respect to the railing or fence. NO ADDITIONAL WARRANTY SHALL BE EXPRESSLY GIVEN, LEGAL OR IMPLIED WARRANTIES OF MARKET VALUES FOR A PARTICULAR PURPOSE, WHICH WILL BE EXPRESSLY DISCLAIMED HEREIN.
